JUDGE THOMAS MONTGOMERY.

Judge Thomas Montgomery, born in Virginia in 1876, sixth child of "Purty Old Tom" and twin to Judge Isaac Montgomery. He was a Democrat, and his twin brother a Whig. The two parties in Gibson county, Ind., nominated them for the legislature. Thomas was defeated in this race. However, he was a very prominent and popular man. He was elected county commissioner in 1817. In 1820 he was elected one of the associate judges of Gibson county, and continuously elected to that office for 26 years. He first married Betsy Warrick. in Kentucky, a sister to Captain Jacob Warrick. He settled on what is known as the old James Stewart farm in Montgomery tonship, Gibson county, Ind. Fourth he married Christina McCleveland, a mere girl, whom he married in his old age, which proved to be rather an unfortunate marriage.

WALTER CROCKETT MONTGOMERY

Walter Crockett Montgomery was born at the head of Roanoke Springs, Virginia, in 1784. He came with his father, "Purty Old Tom." to Mt. Sterling, Ky., 1796, and then to Gibson county, Ind., in 1806. He designated himself as "Old Virignia Walter." He was known all over Gibson county as being the owner of the stallion "Old McKinuey Roan," the noted race-horse of those early days in Indiana, which was never outdistanced on the race track. This noted horse was admired by all parties when he was on dress parade on public occasions, such as plection days and muster days. He had been trained from a colt to leap over a pole held up for that purpose, and on those public occasions he took as much pride and interest in his exploits as did his admirers and owner. The pole at first would be held at three feet, "Old McKinney Roan" always leading in the leap, nearly all the other horses on the ground would follow suit up to five feet, then they would fail, or try to run under the pole. Then the pole would be raised by inches, and "Old Me-Kinney" would clear it at a height of six feet. Then he would curl his tail over his back and prance so elastically that "Old Virginia Walter" would declare "the horse could walk on eggs and not break them."

Mr. Montgomery and Gen. William Henry Harrison were well acquainted in Virginia and renewed their acquaintance in Indiana, and the general often stopped over night with Mr. Mongomery while he was looking after the interest of Indiana Territory between Vincennes and Mt. Vernon. Mr. Harrison appointed Mr. Montgomery sheriff of Knox county, out of which several counties were afterward formed. He was a soldier in the war of 1811-12, in the company of Capt. Jacob Warrick, who was his brother-in-law. Mr. Montgomery died Jan. 14, 1856, and was buried in the old family cemetery in which his father, "Purty Old Tom," was buried in 1818, on the farm he settled on in 1807. He first married Nancy Roberts, born June 1790, died Jan. 1815, of the disease then known as "black-tongue," which proved so fatal in that day. Children thirteen. Second he married Margaret Powell, Nov. 23, 1845, who was born Feb. 4, 1812, died Dec. 11, 1894; children six:

1. Matilda Montgomery, born June 23, 1809, died June 13, 1857; married Asa Knowles, born March 5, 1802, died July 6, 1898; therefore he was 96 years old. He was born in Georgia: lived on a farm west of Owensville, Ind., until most of his family was grown. Then he sold out his farm, probably about 1860, and went into the hotel business at Princeton, which was a very bad move. He moved from Princeton, Ind., to Greenwood county, Kansas, when probably 70 years old. He was a Democrat, and a staunch Cumberland Presbyterian, and a few years before his death he wrote a little pamphlet setting forth his views on baptism and other matters and sent many of them back to Indiana to his relatives and friends. The Knowles people in Indiana, wished to hold a reunion in the grove of John Lowery Knowles, a half brother of Asa. "Uncle Asa" was a disbeliever in such thinsg and opposed it vigorously; but finally, through the pressure of old friends, he consented to be present, and he afterward made a full confession of his error in this matter, saying: "I believe I have met one thousand of my relatives and friends, since coming to this two-days reunion, that possibly I never would have met again in this life if I had not attended this meeting." He was a Knowles and married a Montgomerv, which connected him to nearly all the people in Montgomery township. He was a disbeliever in the medical profession. He was quite sick at the reunion, and the writer suggested that he call a physician. He said: "No, sir: I never had a doctor to see me but once in my life, and he came pretty near getting me that time, so I take no more medicine."

Matilda Montgomery, his wife, was a grand, good woman, born 1809; was a twin to Thomas Montgomery. This is a characteritsic which belongs to the Montgomery family in Gibson county, and it has more or less followed the family ever since 1776, when Judge Isaac and Judge Tom, sons of "Purty Old Tom," were born in Virginia; and I have noted 55 pairs of twins, the majority of them being descendants of "Purty Old Tom." Children seven:

1, America Knowles, born Oct. 16, 1830, married Thompson G. Mauck, Sr., Nov. 13, 1851. He was born Sept. 6, 1830. He belongs to an old and well-respected German family: lives west of Owensville. Ind., and has been engaged in farming all his life. He is a member of the Regular Baptist church of Owensville. America Knowles, his wife, was an exceptionally good woman. She was a member of the C. P. church. She died Oct. 20, 1892; children five:

R. church and a stockholder in the Owensville Milling Company. John A. Mauck, born Oct. 12, 1862, fifth child of T. G. Mauck. Mr. Mauck was head clerk in the Farmers department store in Owensville, and is now (1903) in the department store of G. R. Welborn; married Ada Robinson, Aug. 10, 1887; children two: 1, Bernice Mauck, born Mar. 11, 1893; 2, Hilda Louisa Mauck, born May 17, 1902.

Sarelda and Nancy Knowles, 2 and 3, children of Asa Knowles, died in infancy.

Sarah Knowles, born Dec. 3, 1833, fourth child of Asa Knowles, married Thomas Fisher, Feb. 4, 1865. He was a soldier in the 24th regiment Ind. Vol.; was severely wounded, from which he finally died, probably about 1895. Mrs. Fisher now lives in Virgil, Kansas; children two: 1, Albert S. Fisher, born June 19, 1867, died April 10, 1883. 2, Joseph W. Fisher, born Jan. 9, 1875.

Elizabeth Knowles, born about 1835, fifth child of Asa Knowles; married William Tolbert. He was a soldier in the first reigment Ind. Cav.; died in Virgil. Kansas, where his wife now lives; children seven: 1, Minnie R. Tolbert, dead. 2, Luella C. Tolbert, married Horace G. Marshall; children four: Elsie, —, Ben and Beulah. 3, Asa M. married Grant Hollins; children two—sons 6, Matilda J. Tolbert, married Earl Russell; one child, ——. 7, Gilbert Tolbert.

Patience Knowles, sixth child of Ara Knowles, married Clinton Simpson. He died in Owensville, Ind., and she lives in Virgil, Kansas; children three: 1, Sarah. 2, Laura, died Sept. 16, 1877. 3, Georgia.

Martha Knowles, born Sept. 19, 1846, seventh child of Asa Knowles, married Alfred Mauck, Oct. 1868, in Indiana; moved to Toronto, Kansas. and Mr. Mauck died there Dec. 31, 1888. Mrs. Manck and nearly all her family moved to Salubria, Idaho, in 1902; children four: 1, Mary T. Mauck. born July 8, 1869, in Indiana; married Andrew Case, Oct. 31, 1895, at Toronto, Kansas; no children. 2, Nannie A. Mauck, born April 20, 1871, in Indiana, married Thomas Harris. July 2, 1894; children three: 1, Janie O. Harris, born April 27, 1895; 2, Alice L. Harris, born Feb. 14, 1898; 3, Jesse W. Harris, born Aug. 7, 1900. 8, Cornelia A. Thomas Montgomery, born June 24, 1809; a twin to Matilda above, and second child of Walter Crockett Montgomery, Sr.; married Betsy Gambrel, sister to Henry and Thompson Gambrel. They moved to Atlanta, Ill., Oct. 1848, and he died there in 1853.

Hon. J. W. Montgomery, born Feb. 6, 1811, third child of Walter C. Montgomery, Sr., married Jane McFadin Oct. 4, 1835. She was born Oct. 15, 1814; was the daughter of John McFadin, Sr. (See index for John McFadin.) She lived in Owensville when only four families lived in the town; she lives there now (1903), though most of her life has been spent in the country on a farm. She is one among the best women I ever knew.

J. W. Montgomery was a great reader, kept up with news of the day. He had a remarkable memory and was one of the best-posted men in the country. He knew something of the history of every representative in the National Congress, from Jackson's administration down to the closing years of his life. He represented Gibson county in the Indiana legislature in 1875-6. He was generous to a fault; never turned a neighbor away empty-handed when it was in his power to help him. He never refused lodging to a traveler in his life.

To illustrate, probably about 1850, Earl Robinson, who was full of pranks and jokes, had been to Owensville one day and late in the afternoon, on his return toward home, he fell in with a stranger on

horseback who was traveling his way. When they reached a byroad leading off to Robinson's house, the stranger asked to be entertained over night. This was Robinson's opportunity for a little fun.
He replied: "I would keep you, sir, but it would not be treating
the U. S. government right, as it has a station just over the ridge
there and employs a man by the year to entertain all strangers free
of charge"—at the same time describing the man, house and surroundings so there could be no possibility of a misake.

The stranger found Mr. Montgomery just starting out to do up the night feeding, and asked for a night's lodging. "Certainly," replied Mr. Montgomery, at the same time throwing open a large gate that led into a wood-lot adjoining the yard, allowing the stranger to ride in, then saying: 'Hitch up your horse, go into the house, make yourself comfortable. The boys will soon be in and take care of your horse."

As soon as Mr. Montgomery came in from work the stranger said: "This is certainly a very fine arrangement the government has for entertaining the traveling public," and then related what Mr. Robinson had told him. Mr. Montgomery carried out the joke, asking no questions as to what kind of man it was, saying afterward that he knew very well who the informer was.

The next morning when the boys caught, bridled, saddled and brought out the horse, the stranger said: "Mr. Montgomery, this is a remarkable arrangement; but, notwithstanding the government pays all expenses, it seems to me that I should at least pay you something, as you have treated me with so much consideration."

"No, sir, the government has made ample provision for me, sir."
The stanger reluctantly put his money back in his pocket, and with many thanks proceeded on his journey—probably never finding another government station equal in hospitality.

Mr. Montgomery was very entertaining in conversation. He had an almost inexhaustible fund of ready material to attract and interest his hearers. He had eight children:

1, Permelia Montgomery, born Aug. 27, 1836, married John Jones, Sr., in Gibson county, Ind., Oct. 30, 1856, and moved to near Midland, Ill., which is one of the most beautiful sections of the state; children six. See page 128, John Jones.

2, Lucinda Montgomery, born April 21, 1838, died March 17, 1872; married James C. Pruitt, Nov. 27, 1862. Mr. Pruitt is a merchant in Owensville, Ind.; children two: 1, Lernando Pruit, born March 24, 1864, died Nov. 8, 1865. 2, Joseph Pruitt, born March 10, 1872, died July 24, 1872.

3, Walter Crockett Montgomery, born Dec. 6, 1839; lives in Owensville, Ind., and deals in nursery stock; first married Theodocia McCrary, Nov. 18, 1862. She was born Dec. 19, 1845, died Sept. 25, 1870. Children five: 1, Emma E. Montgowery. born Nov. 20, 1863; aied Sept. 18, 1870. 2, Clarence E. There was a terrible epidemic of flux in the fall of 1870, and you will observe that Mr. Motgomery lost his wife and four children—his entire family except one, which died in 1868.

Cook, a hardware dealer, Dec. 25, 1902. They live in Indianapolis, Ind. 5, Warrick M. Montgomery, born Feb. 18, 1882. died Aug. 14, 1882.

Martha J. Montgomery, born July 29, 1841, fourth child of J. W. Montgomery; maried Henry Clark, a farmer, July 25, 1861. He died Feb. 22, 1880. He was a brother to Rev. Wm. Clark and a very useful man in Christian work. Mrs. Clark lives in Owensville, Ind.; children nine:

Montgomery, daughter of "Roan Ike" Montgomery, May 6, 1875. They are stockholders in the Owensville Milling Company; no children, but they raised Burgess Montgomery and Elsie Ayers. See pages 174 and 198.

William W. Montgomery, born March 7, 1852, died Aug. 19, 1856; seventh child of J. W. Montgomery.

Joseph Montgomery, a carpenter, born July 17, 1854, eighth child of J. W. Montgomery; taught in the public schools; lives near Midland, Ill.; married Mary A. Yeager. Oct. 6, 1879; no children.

Joseph Montgomery—"Long Armed Joe"—born Oct. 27, 1813; fourth child of Walter C. Montgomery, Sr.; married Nancy Hughs, about 1837. He cut trees, and rolled in logs on the first levee to Mt. Carmel, on the Indiana side, and ditched both sides. Most of his work was accomplished by his own strength and labor. He was 6 feet 4 inches tall and weighed 204 pounds; raw-boned, with arms about four inches longer than those of most men of that day, which made him a disagreeable opponent in the common contest of that time. He was always smiling, even in the contests in which he frequently engaged-always with success. He never was the aggressor. There was only one way that he could be made to fight, and that was for a man to strike him first, which frequently happened; but no man ever desired to bring on a second contest. In assisting to let a loaded wagon down a hill, on the farm now owned by Marion Thompson, a wheel struck a root and switched the wagon-tongue. throwing him down, and one wheel ran over his neck. He spoke and said, "My neck is broken," and died. This occurred Oct. 23. 1848. He had four children:

Thomas Montgomery, a farmer, born Aug. 5, 1839; married Lousanna Rutledge, Nov. 5, 1863, in Indiana; moved to Neodesha, Kansas, in 1886; died there Oct. 20, 1899; children six, all born in Indiana: 1, Willard, born Dec. 28, 1864, died in Kansas, Jan. 20, 1894. 2, Edward N., born Nov. 11, 1866; was in the California Heavy Artillery in the Spanish-American War. 3, William Joseph, born Oct. 24, 1868, enlisted in the Spanish-American War but was rejected. 4, Arthur, born Feb. 16, 1874, enlisted in the Spanish-American War but was rejected. 5. Leonard, born Dec. 13, 1875, taught in the public schools of Kansas; died Dec. 23, 1901, in Pueblo, Cal., from having stepped in a vat of scalding water, at the machine shops, where some one had neglected to shut down the door. He was a graduate of a high school; at the time of his death was in the employ of a railroad. 6, Lawrence, a twin to Leonard, born Dec. 13, 1875; lives with his mother near Neodesha, Kansas.

2, Isaac Montgomery, a twin to Thomas, born Aug. 5, 1839, died small.

3, Frank Montgomery, born June 2, 1841, and—4. Mary E. Montgomery, his sister, born Feb. 22, 1846; both single 1903 and living in Neodesha, Kansas, in comfortable circumstances.

Isaac Montgomery, born May 5, 1815, fifth child of Walter Crockett Montgomery, Sr.; first married Polly Teel, in Indiana, probably about 1837. He was father a small man, never weighig over 135 pouds. She was over six feet tall and an ideal, good woman. They moved to Atlanta, Ill., in 1854, and she died there; children six. He married a second time, but I do not know whom; one child. ——. Isaac came back to Idiana in 1856 and died the same year. Children seven:

1, Walter C. Montgomery, born probably 1838, was a soldier in the 24th regiment Ind. Vol.; never married; died in Owensville a few years after the war.

2, Dr. W. T. Montgomery, born probably 1840, was a soldier in the 33rd regiment Ind. Vol.; lived with Asa Knowles, who married his father's sister, Matilda, already mentioned, after 1856 until he enlisted in the army. He entered and remained in the army until the close of the war, when he prepared himself for teaching. In 1838 he entered Lincoln College, in Illinois. In 1869 or '70 he entered Rush Medical College, in Chicago, Ill., from which he graduated in a regular course; practiced medicine in Chicago for several years, then became a specialist in eye and ear.

Later he visited Europe in the interest of his profession. In 1900 he again visited Europe, and remained abroad several months. He is now located in the new Marshall Field building, Washington Street, Chicago, and is enjoying a very lucrative practice. He has been married twice, but no living children; had one infant by his first wife.

3 and 4, Infant twins, born about 1843, children of Isaac Montgomery.

Thomas Montgomery, born probably 1846, fifth child of Isaac: engaged in the stock business in Kansas, and died there unmarried.

Nancy Montgomery, born probably 1850, sixth child of Isaac, married Nicholas Boren, of Princeton, Ind.: no children.

7. Louis Montgomery, born 1856, in Illinois, son of Isaac by a second wife; visited Indiana after he was grown. The last I heard of him he was in Missouri, unmarried.

So far as I know there is not a living grandchild of Isaac Montgomery.

John Roberts Montgomery, born May 4, 1817, married Rachel B. Brumfield about 1840. He died 1856. His wife died 1879. He was of rather heavy build, sandy curly hair, and blue eyes. She was slender with straight, black hair and black eyes. Children six:

1, Richard Montgomery, born June 16, 1841, was a soldier in

Co. F, 80th regiment Ind. Vol. He was captured at London, Tenn., in 1833, while repairing the telegraph line. He was several months at Belle Island, opposite Richmond, Va., then taken to Andersonville, Ga., where he died Aug. 15, 1864. His remains are supposed to have been removed to Chattanooga, Tenn. His name is recorded on the family monument of D. B. Montgomery, his brother, in the Joseph Clark cemetery in Montgomery township, Gibson county, Ind. He was never married.

2, Walter C. Montgomery, horn May 26, 1843, second son of John Roberts Montgomery, was a soldier in Co. F, 80th regiment Ind. Vol.; was in the Perryville fight with the regiment, Oct. 8, 1862, which had left Camp Gibson, at which it was organized, just one month to a day. He was severely wounded at Kenesaw Mountain, from which he is a great sufferer at the present time. He lives in Owensville and is in comfortable circumstances. He married Louisa Clark, a sister to Rev. William Clark, Sept. 8, 1870. She was born Oct. 13, 1847; children five:

1, Lillie B. Montgomery, born July 5, 1871, married George N. Yeager, March 13, 1890, a farmer and breeder of poultry and stock. One child—Lulu Yeager, born July 20, 1891.

2, John Montgomery, born July 6, 1873, is a liveryman in Owensville, Ind., and treasurer of the Town Board of Owensville, 1902; married Minnine Marvel, Dec. 13, 1893; one child—Ureta F. Montgomery, born Sept. 22, 1894.

David B. Montgomery, born Oct. 20, 1845, third child of John Roberts Montgomery. He was one of editors of the General Baptist Herald from January 1874 to January 1875. He published a history of the General Baptists in 1882. He has in manuscript a Life of Rev. Dr. A. D. Williams, late president of Oakland City College, Oakland City, Ind. He is also the compiler of this Genealogy. He married Nancy Jane Smith, daughter of John Martin Smith, Oct. 1, 1874. She was born Jan. 25, 1852, and died March 24, 1899. Children two:

They were married in Indiana and moved to Udall, Kansas, in 1886; took a claim in the Territory in 1888, and he died in 1889. She was left with four small children, therefore she was allowed to return to Indiana and remain until the final proving up of her claim. She remained in Indiana until the fall of 1899, when she and all her family except Jessie returned to their farm in Oklahoma. She married George W.
